Dear Mr. Peevey,

The City Council of San Luis Obispo requests PG&E immediately suspend the installation of SmartMeters in the City of San Luis Obispo until an opt out procedure is finalized and made available to the public.

This request is made pursuant to numerous public expressions of concern regarding health, privacy, safety, and environmental risks associated with SmartMeter technology.

While PG&E has proposed to CPUC to offer customers the option to pay \$250 upfront and \$20 per month to have their SmartMeter radio transmitter deactivated, our collective desire is for PG&E to develop and implement a zero-cost option by which San Luis Obispo residents may either opt out of SmartMeter installation or request deactivation of the radio transmitter. Additionally, individuals moving into a residence with an existing SmartMeter should have the option to request the SmartMeter be uninstalled and replaced with an analog meter.

We appreciate your immediate attention to this matter and your effort to ensure the residents of San Luis Obispo may continue to thrive in a healthy and safe environment.
